Please Note - New Policy:

A \$200 rent deposit is required by all weekly, and bi-weekly vendors at the beginning of the season.

a. Market rent will be applied from that deposit, if a vendor doesn't come to market on a day that we're open, and they're scheduled to be there.

b. If weather conditions force the market to close early, and vendors are unable to do business, then no rent will be charged for that day.

c. Any amount of the deposit not used to cover rent, will be refunded to the vendor within 60 days after the season closing date.

We understand there may be extenuating circumstances why a vendor might not be able to attend a market day, (health, etc.) a decision will be made by the market manager on that day as to whether or not rent will be charged.
